Matters Arising:

Reply from the 'Post office': - Letter had been delivered daily in Rhoscolyn in the previous 6 weeks, they provided assurances that the mailboxes are, and have been, emptied every day.

Tysir Stile: – Cllr. S. Hanbury drew attention to the condition of the stile – IOACC to be notified of this.

Inviting an Officer from IOACC. – discussion postponed because Cllr. W. Roberts (who proposed this at the previous meeting) was absent from the meeting.

New Clerk Appointment: – No response to the advert - names were put forward to contact to see if they were interested.

Future meetings: After discussing various options, agreed to meet on Thursday evenings every six weeks.

Other Local Matters

1. Agree to cover the cost of the translator (£138)
2. Agree to donate £250 towards children's prizes, entertainment, etc. for the Jubilee party in the hall.
3. Cllr. Bloor drew attention to a pole placed at the entrance of the path down to the water – contact to C.S.Y.M. to see if this is acceptable.
Complaint also made about the vehicles parked on the path down to the water in front of Ty Fynnon when companies were practicing on the water – Ask C.S.Y.M if companies were allowed to do so and propose they should be warned that they should not park there after disembarking – they were preventing others from reaching the water.
