Cais o dan Adran 73 ar gyfer amrywio amod (02) (Cynlluniau wedi eu cymeradwyo) o ganiatad cynllunio cyfeirnod (FPL/2021/174) (Cais llawn i ddymchwel anheddu presennol a chodi anheddu newydd, creu mynediad newydd, addasiadau i fynediad presennol yngyd a gwaith cysylltiedig) er mwyn caniatau cynlluniau diwygiedig - Roedd y Cyngor o'r farn na ddylid ymdrin â'r cais hwn fel amrywiad o gais gynllunio gan fod y cynlluniau diwygiedig yn sylweddol wahanol i'r rhai a gytuwyd arnynt yn flaenorol. Felly dylid gofyn i'r ymgeisydd gyflwyno cais newydd ar gyfer cynllunio.

Minutes of the Council Meeting – 7pm Thursday, 6 April 2023 (Zoom Meeting)

1. **Apologies** Councillors Elwyn Owen and William Roberts.
2. **Declaration of Interest** - County Councillor Trefor Lloyd Hughes declared an interest in planning matters. Cllrs. Iwan Jones and Tony Thompson declared a personal interest in item 5.3.
3. **Minutes of the previous meetings** - the minutes of 23 February 2023 were accepted as correct.
4. **Matters arising from the minutes**
 - 4.1 Parking issues by Maes Llety – this matter was ongoing.
5. **Planning**
 - 5.1 **VAR/2023/18 Gwynfryn Lodge, Rhoscolyn**
Application under Section 73 for the variation of condition (01) of planning permission reference 43C54G/VAR (erection of a dwelling) so as to allow a further 5 years to commence development – no objections.
 - 5.2 **VAR/2023/17 Plas Huan, Rhoscolyn.**
Application under Section 73 for the variation of condition (02) (Approved plans and documents) of planning permission reference (FPL/2021/174) (Full application for the demolition of existing dwellings and erection of replacement dwellings, creation of new access, alterations to existing access together with associated works) in order to allow amended plans – the Council was of the view that this application should not be dealt

with as a variation of planning as the revised drawings were considerably different to the previously agreed plans. The applicant should therefore be asked to submit a new application for planning.

5.3 FPL/2023/82 Rhyd y Bont, Four Mile Bridge

Full application for the conversion of an existing farm outbuilding into a self-contained holiday let unit together with the installation of a package treatment plant and soak-away – no observations.

Cllrs. Iwan Jones and Tony Thompson declared a personal interest in this item.

6. Correspondence: submitted and noted.

- 6.1 Consultation: Planning Policy Wales on net benefit for biodiversity and ecosystems resilience

7. Financial Matters

Members were presented with details of the accounts to 31.3.2023 and an estimated list of expenditure to 30.9.2023. The uncertainty regarding the audit costs was still of concern and all expenditure would be monitored very carefully to ensure there were sufficient funds for this. In the meantime the £2500 put aside to support educational initiatives would have to be held in reserve.

7.1 Payments to be made

In view of the fact that there were no charges for translation for April it was agreed to donate £100 to assist with the cost of the Coronation Celebrations at the Village Hall.

7.2 Membership One Voice Wales

The Clerk had been informed that the Community Council would have to pay retrospective fees for 2021-2022 before they could re-join One Voice Wales. This was because One Voice Wales had deemed that the Council's Membership would continue although they had not received confirmation that Rhoscolyn Community Council wished to join again that year.

It was agreed that the Community Council would not become members of One Voice Wales at this time.

- 7.3 Appointment of Internal Auditor – Agreed to ask Mr Hughie Lloyd Jones whether he was available to carry out an internal audit of the accounts.

8. Other Parochial Matters

- 8.1 Footpaths – to be discussed in the May meeting.
- 8.2 New 20 mph speed limits – it was agreed to ask for an exception to this rule through Four Mile Bridge.
- 8.3 Bryn Môr, Rhoscolyn – concerns had been raised about the appearance of large stones around the grassed area next to the property. The ground belonged to the County Council and was to be used for parking as and when required. IOACC had been informed and the matter had been dealt with. The Community Council would monitor the situation.
