**Minutes of the Annual Meeting - 7.00pm, Thursday 18 May 2023**

**1. Apologies:** Councillor Iwan Jones.

**2. Election of Chairman 2023 – 2024**

With Cllr. E.W. Robertson proposing and Cllr. S. Hanbury seconding Cllr. Barry Thomas was re-elected as the Chairman. All agreed.

**3. Election of Vice- Chairman 2023- 2024**

With Cllr. E.W. Robertson proposing and Cllr. W. Roberts seconding Cllr. Susan Hanbury was elected as Vice-chairman. All agreed.

**4. Election of Representatives – the following were elected:**

- 4.1 Town and Community Council Liaison Forum – Cllr. S. Hanbury agreed to represent the Council but one other could also attend the meetings.

**6. Minutes of the last meeting**

The minutes of 6 April 2023 were accepted as being correct (Proposed Cllr. T. Thompson, seconded Cllr. E.W. Robertson.)

**7. Matters arising from the minutes - none**

**8. Planning**

**8.1 VAR/2023/23 Plas Uchaf, Rhoscolyn**

Application under Section 73 for the variation of condition (02)(Approved plans), (03)(Sparrow nest boxes) and (04)(Bat boxes) of planning permission reference HHP/2021/236 (alterations and extensions with balcony) so as to allow amended external material choices – no objection.

**8.2 HHP/2023/85 Ty Rhos, Pontrhydybont**

Full application for the erection of a workshop - Members raised concerns raised about the height of the building if it was to be used as a workshop / storage area for a motor home and the proximity to the boundary of the neighbouring property. It was also noted that the site was within the AONB. Agreed to request that if the application was to be agreed that it be on the condition that it was not to be used for any commercial or residential purposes.

**10. Financial Matters**

Submitted: the financial report for the period from 1.4.2023 to 30.4.2023 together with bank reconciliations, statements and copies of the accounts.

The external auditor's costs were still not known. It was agreed to pay the two years payment demanded by One Voice Wales in order to receive training at the lower member's rate. It would also allow the Council to apply for the bursary offered by the Welsh Government for training.

It was also agreed that the £10,000 sum included on the Insurance Documents was as

accurate a figure possible for the value of the two bus shelters and benches included on the Asset Register.

Mr Hughie Lloyd Jones had agreed to carry out the Internal Audit of the 2022/23 accounts – the clerk would present the documents to him as soon as possible.

- 10.1 Insurance – agreed to accept the Zurich quotation for 2023-24.
- 10.2 Financial Risk Assessment – the Chairman had suggested that this should include the risks associated with the meeting venue etc. The clerk would look at this.
- 10.3 Members Allowance Policy - updated to reflect the changes put forward by the Independent Remuneration Panel for Wales.

It was also agreed that the RFO should pay for the translation costs if they arise before the next meeting.

## **12. Parochial Matters**

- 12.1 Footpaths – the contractor had started cutting these.
- 12.2 Saltings, Four Mile Bridge –the Community Council would be working with IOACC to try and resolve the parking issues. Members of the public had identified further issues with dog fouling and the dumping of grass cuttings on the green. The clerk would make further enquiries about this.
- 12.3 Temporary Road Closure - Four Mile Bridge to Rhoscolyn Road -necessary to install a new gully and associated works on Rhoscolyn School Lane.
- 12.4 Local place names – Cllr. Susan Hanbury expressed concerns about the number of Welsh place names that were being lost in the area, it was agreed to find out whether any funding was available to provide new signage etc.
- 12.5 Consultation Order 202: proposed speed limit B4545 (126 meters North East of Junction Copperfield Close towards 573 meters towards Valley) – the Community Council was opposed to reducing the speed limits to 20mph.
- 12.6 Other reports

Cllr. William Roberts: expressed concerns about the acoustics in the hall and asked whether an application for funding could be made to the County Council. It was agreed that this type of grant application would have to be made by the Hall Management Committee however the Community Council would look at assisting with improvements when funds became available.

Cllr. Barry Thomas: reported that the stretch of road between Rhoscolyn School and Cnwc Melyn also required attention as the road surface was breaking up.

Cllr. Elwyn Owen: expressed concerns about the number of posters / notices that were being left to rot - they should be removed immediately after each event. Agreed to monitor this.

Cllr. Susan Hanbury: reported that the recent issue with parking by Bryn y Môr appeared to have been resolved – agreed to monitor this.
