### Matters arising

New clerk appointment : - Chair explained that one application received – Ffion Thomas from Valley. Having received information about the applicant it was unanimously agreed to appoint her. Appointment Committee to meet with her on 3rd of August to discuss details.

Planning:- 4 applications received, no objections to the applications at Bronddel, Fferam Plas or Ty Tudur. Strong feelings about the proposed developments in Hirfron (not good for the environment, large windows, bright lights illuminating the surrounding area, also owls nesting in the vicinity.)

Correspondence:- IOACC named new Director of Education - Marc Berw Williams: Local housebuilding schemes in Llanfachraeth: Units on Penrhos Estate; Money to help buy fresh foods for the food banks (Using allotments to the Island): information on census figures on Anglesey: Applications for the Standards Committee.

### Other Local Matters

1. Cllr. S. Hanbury made reference to the launch of "Our History" (Goronwy Parry's experience of the second world war in Rhoscolyn – being questioned by 3 pupils from Ysgol Rhoscolyn) 3rd August at 6.00 in the Hall.
2. Pointing out the condition of the road, praise for the work done, request that the job be completed.

4. Greg Palmer had cut the footpaths – agreed to pay him.
5. Need to identify place names that were in danger of being lost because some were giving them English names. Discuss and prepare a list at the next meeting.
