Actions of previous meetings

Responses for IOACC

Stile at Ty Sir – warning has been sent to the owner of the field. Failing a response IOACC have arranged for the repair and will recover the costs from the owner. – **CLOSED**

Pole on the public footpath – placed in location by the Maritime Department. The pole does not affect the footpath – **CLOSED**

Parking in front of Tyn Ffynnon – it's unlikely that the companies involved are asking for permission to park there. Contact IOACC Maritime Department. **ACTION FT**

Numbers and speed of cars through Four Mile Bridge – There is no historic record on file by IOACC. They will arrange for reporting instruments to be installed and will create a report. Information will be shared upon completion. **OPEN**

Road in Rhoscolyn – Need to contact Darren Owen from IOACC to explain it is the road from the chapel to the School – **ACTION FT**

Dog Waste bin – IOACC will relocate and move the bins around the area to accommodate the needs- **CLOSED**

Payments – Greg Palmer has received a payment of £650 for cutting the footpaths. Cymen have received £138 for translation services.

Planning

- The Nook – To turn the bungalow into a house. Plans have been shared via email from Myfyr. Committee object proposed plans as they do not fit in with the surrounding buildings. Any further comments to be shared with Barry. **ACTION FT** to notify Planning Department of objections

- John Creiglwyd has contacted in regards to people parking in front of Tyn Ffynnon. Mater to be raised with the Maritime Department. Clarity needed on the rights and clear signage needs to be displayed where the owner owns rights. **ACTION FT**
- Parking on the road opposite the council houses. Need to notify Highways Department of this ongoing issues. **ACTION FT**
- 2 'carriageways boxes' have become loose outside Pendref. **ACTION FT** to contact the highways department.
- Sewerage smell by the small bridge in Rhoscolyn. Possibility that it is running down to the river. Contact Natural Resources Wales to inform and investigate. **ACTION FT**
