Actions of last meeting

Parking in front of Ty'n Ffynnon – contacted for update **OPEN**

Number of cars and speed through Four Mile Bridge – contacted to suggest doing the test during Easter 2023 – **OPEN / FOLLOW UP IN MARCH**

Maintenance work on the road in Rhoscolyn - Darren Owen has responded. Work order has been raised for the community team. Also included to fill in holes in front of the church. - **CLOSED**

Number of cars parking in front of the Council houses – Have received a response from IOACC Highways department. A further discussion is needed. DRT suggests talking to the owner of the field. FT to send the letter on to BT. **OPEN**

Carriageway boxes loose outside Pendref – response from IOACC Highways Department – Unfortunately it is not within the criteria to be changed yet-**CLOSED**

List of Welsh Names – Have received a response from Arwel IOACC. He notes if the locations are historical on the public footpath, a application can be put forward to him. If it is to do with the roads a application should be sent to the Highways department. SH to prepare list. **OPEN**

Payments - Delay with HSBC paper work. FT has contacted for a update. Contact Myfyr to get a list of signatories. Contribution to the Rhwyd, Myfyr's payment and Cymen invoices are outstanding. – **OPEN**

Sewerage Smell – have contacted IOACC – their response was to contact NRW. Re contacted and awaiting response. **OPEN**

Invite a planning officer to the meeting – Rhys LL Jones apologies for not attending tonight. Re-arrange for his attendance in a future meeting. – **OPEN**

Contribution to Ty Gobaith – Consider a contribution to Penrhos Stanley instead to help local people. **OPEN**

Sign by Ty Woods on the public footpath – Has been noted by IOACC and this will be included in the next work order for repairing public footpath signs. – **CLOSED**

Sign on the gate by Glan Don – Response received by IOACC. They will take responsibility to remove the sign. - **CLOSED**

Map of the area – SH has brought some in. **CLOSED**

Information / book by Ifan E Jones on Rhoscolyn : response by the archives – not to be seen on the system or catalog database. Re-contact to look for Efan E Jones **OPEN**

Screen for the hall– need to ensure it is thick. Everyone to look for some. **OPEN**

Website – FT to contact Huw. Re-search other Community Council websites. **OPEN**

Planning
