1. **Apologies** Councillors Iwan Jones, Elwyn Owen and William Roberts.
2. **Declaration of Interest** - Cllr. Evan Wyn Robertson and Cllr. Susan Hanbury declared a personal interest in planning application 5.1
3. **Minutes of the previous meetings** - the minutes of 12th and 19th January 2023 were accepted and signed.
4. **Matters arising from the minutes**

 - 5.1 LUP/2023/2 Caravan Park, Silver Bay, Rhoscolyn.
Application for a Certificate of Lawfulness for the proposed use of land for the siting of 6 static caravan, together with associated hardstanding, to be occupied for holiday purposes - It was understood that the applicant had permission for a maximum of 220 caravans on the whole site and that the caravan park was already full. It was therefore agreed that it should be emphasised that a 'Lawful' decision should not allow the applicant to increase the overall number of caravans on site.
