- 1. Apologies:** Cllr. William Roberts and County Councillor Keith Roberts.
- 2. Declaration of Interest:** – none.
- 3. Minutes of previous meeting:** the minutes of 26 February 2026 were accepted as correct (prop. Cllr. G. Owen, sec. Cllr. T. Thompson).
- 4. Matters arising from the minutes**
 - 4.1 The new tourist information sign on Borthwen Beach was still incorrect, the clerk was awaiting a discussion with officers from IOACC on how the matter was to be resolved.
 - 4.2 The clerk was expecting a response from officials from Highway Maintenance, IOACC regarding the condition of the road past the school towards the Council Houses in Rhoscolyn.
- 5. Planning Matters – none.**
 - 5.1 HHP/2026/24 10 Ffordd Caradog, Pontrhydybont
Full application for alterations and extensions – no objections.
 - 5.2 FPL/2026/36 Caravan Park, Silver Bay, Rhoscolyn - The Council was opposed to the additional 6 caravan / lodges that had been situated outside of the approved boundary of the park. The 6 additional units had been installed on ground that has been considerably raised to accommodate them, and the view was that making drastic changes to the level of the land and extending the boundary of the caravan park within the AONB was totally unacceptable and should not be allowed.
 - 5.3 Parc Gwyliau Silver Bay Holiday Park, Rhoscolyn
Llythyrâu gorfodaeth / Enforcement letters – noted.
 - 5.4 HHP/2026/2 Glasfryn, Pontrhydybont.
Full application for alterations and extensions – no objections.
