1. Apologies: Councillors Mike Bloor and Iwan Jones.

2. Declaration of Interest: – none

3. Minutes of previous meeting: the minutes of 30 may 2024 and 25 Jume 2024 were accepted as correct (prop. Cllr. T. Tompson, sec. Cllr. W. Roberts.) and (25.6.2024 prop. Cllr. S. Hanbury, sec. Cllr. E.W. Robertson).

4. Matters arising from the minutes

- 4.1 Cllr. T. Thompson had looked at the details of several 6 x A4 sheet notice boards from Greenbarnes Noticeboards, Notice Board Company (UK) Ltd. and Amazon.co.uk: Stationery & Office Supplies and was of the view that Ref AF30/6A4 from Greenbarnes was the best choice for attaching to the bus shelter in Pontrhydybont. Resolved unanimously to purchase this.

- 4.2 The parking issues in Pontrhydybont were ongoing.

- 4.3 The Highways Department were due to inspect the road surface between the primary school and the Council Houses in Rhoscolyn.

- 5.1 **FPL/2024/133 Borthwen, Rhoscolyn**
Full application for the demolition of the existing dwelling and garage, erection a new dwelling with balconies and erection of detached boathouse, alterations to the existing vehicle access, replace existing septic tank with new septic tank together with soft and hard landscaping - It was considered that the proposed development would spoil the character of the AONB and that the likely increase in traffic would cause further congestion on the narrow access road. If agreed the amount of construction traffic would require careful management to avoid becoming a problem to other road users.
