RHOSCOLYN COMMUNITY COUNCIL Minutes of the Annual Meeting - 7.00pm, Thursday 30 May 2024

1. Apologies: Councillors Mike Bloor, Iwan Jones a Keith Roberts – County Councillor.

2. Election of Chairman 2024 – 2025

With Cllr. S. Hanbury proposing and Cllr. W. Roberts seconding Cllr. Barry Thomas was re-elected as the Chairman. All agreed.

3. Election of Vice- Chairman 2024- 2025

With Cllr. E.W. Robertson proposing and Cllr. W. Roberts seconding Cllr. Susan Hanbury was elected as Vice-chairman. All agreed.

4. Election of Representatives – the following were elected:

4.1 Town and Community Council Liaison Forum and One Voice Wales – Cllr. Barry Thomas was happy to continue to attend the meetings but anyone else could also attend.

Cllr. S Hanbury would continue to represent the Community Council as a School Governor for Rhoscolyn School.

5. Declaration of Interest – Cllrs. S Hanbury and E.W. Robertson declared a personal interest in item 8.1.

6. Minutes of the last meeting

The minutes of 18 April 2024 were accepted as being correct (Proposed Cllr. T. Thompson, seconded Cllr. S Hanbury.)

7. Matters arising from the minutes - none

7.1 The clerk was to obtain prices for a 900 x 500 aluminium notice board.

7.2 Cllr. W. Roberts asked for double yellow lines at the entrance to the 'Saltings' as vehicles parking there were obscuring the view when pulling out of that junction. The clerk would contact IOACC.

7.3 Members were still concerned about the road surface between Cnwc Melyn and the school, some work had been done but it wasn't satisfactory.

8. Planning

8.1 HHP/2024/27 Hirfron, Rhoscolyn

Full application for the alterations and extension together with the change of use of outbuildings to form linked additional accommodation, pool house and covered parking. – Agreed to oppose this as members were concerned about the height increase of the outbuildings and the visual impact of that on the open AONB landscape.

**8.2 LUE 2024/10 Caravan Park, Silver Bay, Rhoscolyn,
Application for a Lawful Development Certificate for the existing use of**

the central and eastern section of the park for the siting of 190 static caravans, together with the existing use of the land as an incidental part of the holiday village. – Agreed to oppose this:

There were major concerns about the number of retrospective applications submitted by this company the site was within the AONB and it was thought that a full review of the development was long overdue.

- i. The access lane down to the site was completely unsuitable as it was extremely narrow with very few passing points,
- ii. In addition the expanded development had led to a huge increase in the number of powerful vehicles being driven back and forth at speed with no regard for other users particularly cyclists and pedestrians.

It was agreed that a letter received from a member of the public regarding this application should be forwarded to the Planning Department asking them to note that it accurately reflected the views of Rhoscolyn Community Council.

8.3 Decision LUP 2023/11 Cil y Gwynt, Rhoscolyn.

Application for a certificate of proposed use for the siting of two co-joined mobile shepherd's huts under the General Permitted Development Order - is Lawful

8.4 FPL/2024/95 Cil Y Gwynt, Rhoscolyn

Full application for the change of use for the siting of two co-joined shepherd's huts for holiday let - Agreed to opposed this - considered that the units should not be used as separate holiday accommodation.

8.4 Decision LUP 2024/2 Ty Mair, Pontrhydybont - Granted.

8.5 Decision HHP2024/21 The Igloo, Pontrhydybont - Granted

8.6 Decision VAR/2023/69 Plas Huan, Rhoscolyn - Refused.

8.7 FPL/2024/42 Ty Rhos, Pontrhydybont / Four Mile Bridge.

Full application for the demolition of the existing dwelling and the erection of a replacement dwelling together with associated landscaping works. – Agreed to oppose this:

- i. The proposed dwelling appeared to be far bigger, taller and much closer to the coastline and the public footpath than the existing dwelling.
- ii. It would also be clearly visible from some distance away on the other side of the Inland Sea. (The existing dwelling was fairly hidden prior to the recent clearing of hedgerow).
- iii. The huge expanse of glass would cause light pollution detrimental to the AONB and SSI.
