### Council Meeting Minutes - 7.00pm. Thursday, 3 October 2024

1. **Apologies: Councillor** William Roberts, Evan Wyn Robertson, Tony Tompson and Keith Roberts (County Councillor)
2. **Declaration of Interest:** – none.
3. **Minutes of previous meeting:** the minutes of 22 August 2024 were accepted as correct (prop. Cllr. S. Hanbury, sec. Cllr. E. Owen).
4. **Matters arising from the minutes**
  - 4.1 Pollution in the water by Plas Coch Bridge – this was on going.
  - 4.2 The clerk was informed that the Openreach did not deal directly with the public and that residents struggling with their broadband should contact their providers so that those companies could complain to Openreach. It was also noted that some work was being done on the network in Pontrhydybont.
  - 4.3 Vacant seats – The County Council had prepared the First Notice of vacant seats on the Council, this was issued on 12 September 2024. As there was no application for an election a Co-option Notice would be issued with a deadline of 24 October 2024.
  - 4.4 It was reported that the road towards the Council Houses in Rhoscolyn had been repaired but not resurfaced and some maintenance work had been done by the Hall.
